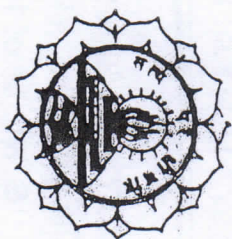


## FIVE COMMANDMENTS OF SHRI VALLABHACHARYA

5. Let your main Goal be enlightenment of the Self and propitiation of Him. To achieve this endeavour to imbibe the ways of a devotee as sung in the 12th Chapter of Geeta and make life Divine. Pure and austere life is the soul of Divine Life. God will never be in the mind seized with attachment to senses.
